## 1. Summary

The Indonesian Government just released a new (temporary) regulation PMK 34/PMK.04/2020 about Tax Exemption for a list of items that may be useful in the battle against Covid-19. A simplified version of the list of items can be found below.

This regulation is applicable until the BNPB deems the pandemic to have passed.

## 2. Terms and Conditions

- 1. The NPWP number must be submitted with a shipment order if there are any items in the order that fall within the list of items that can be exempted from tax.
- 2. Of the list below, 26 items do not need approval and can be shipped normally if purchased in the specified quantity and if the total value of the order is  $\leq 7.5$  million IDR.
- 3. Other items that fall outside the specified 26 items and/or have a combined value that exceeds 7.5 million IDR would have to go through an approval process. Please contact our team at Janio to be advised on this process.
